SPONSOR/VENDOR/PERFORMER AGREEMENT

**Thank you for your interest in participating in F.A.I.T.H.'s Freedom Festival Juneteenth 2026!
Please review the terms and conditions shown below.**

NO SPONSOR, VENDOR, or PERFORMER shall display, sell, or wear any items bearing offensive words or graphics, nor display such in their behavior during festival hours. SPONSOR/VENDOR/PERFORMER MAY NOT sell or display any items that imply or promote violent or criminal acts. F.A.I.T.H. Wellness Services Inc. has the right to expel any Sponsor/Vendor/Performer that in its sole judgment, is out of keeping with the character of the festival. In such case, the sponsor/vendor/performer agreement would be voided, and the offending sponsor/vendor/performer would not be entitled to any refund whatsoever.

LIABILITY: Sponsor/Vendor/Performer agrees to INDEMNIFY AND HOLD HARMLESS F.A.I.T.H. Wellness Services Inc. and F.A.I.T.H. Behavioral Services and Wellness Center LLC., any co-sponsors or any of their representatives or employees for any personal injury or property damages, liabilities, losses, attorney's fees or costs resulting from any cause whatsoever and regardless of fault including any claims resulting from unauthorized or criminal acts of any third party.

PERMITS, INSURANCE, SALES & USE TAX: Each sponsor/vendor/performer must abide by and obtain all required permits, licenses, and insurance needed for the Craig Ranch Regional Park, City of North Las Vegas, Southern Nevada Health District (702-759-1110 southernnevadahealthdistrict.org), and any other required organization/municipality. All sponsors/vendors/performers are responsible for their own tax reporting and collection of all sales tax.

SET-UP & REMOVAL: Set-up time for sponsors/vendors will be announced as the event draws closer. Performers will be provided with their Run of Show time approximately a week before the event date. Please be advised that set-up times and dates are subject to change at the discretion of F.A.I.T.H. and/or Craig Ranch Regional Park. **Two hours before opening, all food/drink trucks/vendors must be fully operational, and all vehicles removed from loading zones and relocated to designated parking areas. All non-food/drink vendors must also have all vehicles removed from loading zones and relocated to designated parking areas. This will be strictly enforced, and no refunds or credits will be issued if you do not complete set-up on time and therefore cannot participate in the event.** VENDORS FURTHER AGREE that dismantling will not begin until 8:30 pm and must be completed by TBD per city and park regulations. SPONSOR/VENDOR shall surrender the premises in clean condition.

MEDIA: Entering this event, as a sponsor, vendor, performer, or attendee, you acknowledge that you may be filmed or photographed with or without audio, and your entry and presence at this event constitutes your total consent and release for the event to use any and all media without limitations or restrictions.

PAYMENT: FULL PAYMENT due upon signing. Acceptable methods include business checks, money orders, and cashier's checks. Returned checks are subject to a \$30.00 service charge. No Refunds or Cancellations. Fee Transfers will be decided on a case-by-case basis.

EVENT CONTENT: All sponsors, vendors, performers, and attendees acknowledge and agree that F.A.I.T.H., in its sole discretion, reserves the right to change any and all aspects of the Event, including but not limited to, the Event name, themes, content, program, speakers, performers, hosts, moderators, venue, and time.

F.A.I.T.H. aims to not have duplicate products and services but does not guarantee such.

FORCE MAJEURE: If either party cannot fulfill its agreed obligations due to a force majeure event, such as acts of nature, war, terrorism, civil unrest, or government actions, the affected party will be excused from performance for the duration of the hindrance. The clause defines a force majeure event as any circumstance beyond the affected party's reasonable control.
